CLIFTON UNITED CHURCH

Bunbury's only church still stands as Clifton United Church on Clifton Road, Stratford. In 1848, the church was built as a Wesleyan Chapel on land given by Capt. James Kelly for the sum of five shillings. The land surrounding the church was already in use as a burying ground. The deeds are dated September 28, and October 19, 1848, and the church was dedicated in the spring of 1849.

A shed was built across the road from the church to shelter horses and wagons or sleighs. Unlike today, service in the tiny church was held year-round. Although the church was heated by a stove, it was still a very cold place in winter. One long-time churchgoer recalled freezing her feet while sitting in church. The ordeal left her unable to attend school the next day.

After Church Union in 1925, Clifton Church became part of the Pownal United Church pastoral charge. On June 5, 1949, special services were held at Clifton United Church, marking the 100th Anniversary of the erection and dedication of the church building. In 1962 it was added to Trinity United Church, Charlottetown, as a preaching place.

In 1994, Clifton Church was recognized as a heritage building by the P.E.I. Museum and Heritage Foundation. A dedication ceremony was held on October 15, 1994, the closest Sunday to the 146th Anniversary of the date of the original deed of purchase. The heritage plaque was presented by the Bunbury Community Council to the descendants of the original church members. In attendance were direct descendants of all the signatories of the 1848 deed.

This historic church is one of the oldest church buildings now used by the United Church on P.E.I. Services are held every Sunday from early June until Thanksgiving in October.

TRINITY UNITED CHURCH

In 1862 the trustees of the First Methodist Church purchased land on the corner of Prince and Sydney Streets for a new church. In May 1863 the cornerstone of the new church was laid.

During the summer of 1863 the masons worked many long hours to finish the brick walls, and by late October the work of raising the rafters began. At the time, few buildings in Canada could boast an unsupported dome roof with a 69-foot span. The building is 115 feet long, 69 feet wide and 42 feet high to the eave. Two octagonal towers on the west wall are separated by a beautiful Gothic window 32 feet high and 15 feet wide. The interior of the church is of Gothic architecture, unobstructed by columns. There were 150 pews on the main floor, seating 900 people, and 78 pews in the balcony seating 650. The actual cost of the new building was \$30,825, including \$843.56 for the cost of the land. The debt at the time of opening was \$9,491. The new church was dedicated and officially opened on November 13, 1864.

The church basement provided 36 Sunday School classrooms with an enrolment in 1865 of some 708 pupils and teachers. Classes were held there until Heartz Memorial Hall was built in 1911. A new Christian Education Centre was opened in 1965. Unfortunately, Heartz Memorial Hall was destroyed by fire in October 1969.

In 1955 a new organ, built and installed by Casavant Freres, was dedicated to commemorate

those who died, and those who served, in World War II and the Korean Conflict. The organ is a three manual and pedal instrument with 48 stops and weighs approximately 20 tons.

Our roots go back to 1778, when Benjamin Chappell invited friends into his home to support and follow the Methodist persuasion. In 1925, Methodist, Presbyterian, and Congregational Churches united to form The United Church of Canada. Today, Trinity-Clifton Pastoral Charge enjoys the benefit of this rich spiritual legacy.

The motto of Trinity United Church is "Have Faith in God." It is with increasing faith that we go forward into the future.

There are many changes happening and are still unfolding. A PEI cluster has been formed which includes the many people from PEI Presbytery. Both the Rev. Melaney and Heather Cameron are sources for information on this new configuration.

10) New Business

Chair Barbara Prowse thanked Ken MacDonald for his more than fifteen years of service as he is stepping away from the work of Church Council. She spoke of Ken's commitment, his

willingness to say I disagree, his understanding of the history of the church and his willingness to research and share so much information. He gently encouraged all members of Council to ask questions even if they are in a situation where it is difficult to do so. Thank you, Ken, for the past fifteen years with Council.

Fundscrip – Ken MacDonald

Ken expressed thanks to Mark and Sandra Richardson, Emily and Vans Bryant, Velda Ward, and Ken MacDonald who each do three months each selling Fundscrip cards. It takes about 4.5hrs a week selling, ordering, pickup new cards and checking orders. Sale of cards were \$4000+ 2018. Can we double that amount? Only 44 families that bought cards during the Christmas time. 10-12 first timers come in during Christmas time.

Mark Richardson commented on Ellen's huge contribution to the project every week.

The Chair reported on the following:

A. Community of Faith Profile (previously JNAC)

To respond to any who are asking this question – are we doing a JNAC - Joint Needs Assessment (Committee) – the answer is – at this time and into the immediate future, 'no'. The purpose of a JNAC is simply to call a clergy. And in the past, because we have been a pastoral charge with two clergy, we would have immediately moved into this process. Because we didn't move into a JNAC, there is a process that we must follow and it has been with the knowledge of the Rev. Cathie Crooks, and under the oversight of the Rev. Kevin MacKenzie, Past Chair of the Presbytery Pastoral Relations Committee and the Rev. Kendall Harrison, Pastoral Relations Minister for our new Region - Fundy St. Lawrence Dawning Waters. This is what we have been up to -

Months ago, with great thanks to Anne Love, Ken and Elaine MacDonald, and Ellen Locke-Doiron, they undertook a count of the actual members and adherents in the congregation.

Adherents, as you know, are those who have not formally joined Trinity-Clifton. This
number is important because it is a factor in determining how many clergy are needed to
support our congregation of members and adherents, and our ministries.

The count is not quite finished but to date - Our count of active *member* households is slightly over 200. Soon we will have a final count of total active households, which will include those who are *adherents*. The final count will most likely be between 275- 320 active member and adherent households. You might remember that when the Rev. Cathie was called, we listed 550 households. We had not done a true count in a long time.

The United Church's position is that one clergy can support about 250 households. Other factors can come into play, but about 250.

In addition to the count, it is important that we remember that we called the Rev. Cathie to a Shared Ministry and that she is working under very different conditions than anticipated when she accepted her original call. Over the coming months, as we define the ministerial needs of the congregation, we all must ensure that Rev. Cathie is fully supported in her ministry here with us and that she continues to be an integral part of these ongoing conversations. At the request of Rev. Kendall Harrison - On February 7, 2019 Council made a motion that requested a delay in proceeding to a Community of Faith Profile. This has been received by

Regional Office and our progress, the household count, the governance structure, our future

ministry needs, will be overseen by the Regional Pastoral Relations Committee.

Other than finishing the count of households, there are some things we will need to do -

- A Vision statement what we want to look like at some point in the future.
- A Mission Statement That will answer Who are we? Who do we serve? What are our needs? What is our purpose?
- And Regional Council is asking all congregations for A self assessment. What do we do well and what do we need to do?

B. Congregation Meeting July 2018 – Renovations to Narthex

If you were present for the Congregation meeting in July you saw wonderful plans for the Narthex – front entry area, steps and doors. At that time, the cost of this project was still unknown.

In September, Property brought a motion to Council that asked that

"Council approve a project budget of \$225,000.00 plus tax to proceed with the renovation of the Prince Street door project as generally laid out in the drawings that were presented at the Congregational Meeting July 15, 2018".

This resulted in considerable discussion and Council agreed to table the motion for up to one year. While the project is a wonderful plan, whether in the long run we can afford to do this, and whether the work of the Ad Hoc Committee on the future sustainability of the Congregation might garner some knowledge that would support this, remains to be seen.

B. Response to Triennial Visit and Carol Gabanna

One year ago, at the Annual Meeting, Council reported on Presbytery's Triennial Visit to this congregation. You may remember that the intent of this visit is to inquire about the health of the congregation.

Following this visit, Presbytery had several recommendations -

There were concerns around Communications and Finances that require ongoing discussions.

There were two recommendations that were more significant. Significant enough that Council believed that we needed to take action.

I will read Directly from the Triennial report.

- Healing Relationships We (Presbytery) believe that intentional efforts need to be made in order to create harmony, respect and a more positive attitude within the congregation. This would include ministry personnel and staff, staff and congregation, and congregation and ministry personnel relationships.
- 2 **Governance**: (And again reading from the report)

The ministry personnel, the Council and the M&P Committee all expressed frustrations with the governance structure suggesting that it is time for the congregation to review the effectiveness of the current structure.

After months of discussion at Council, finally, we agreed to a proposal, a proposal that we had requested from Carol Gabanna. Carol is a Human Resources Specialist, an Islander who works internationally. Her role is to listen to the Council and the members of the congregation who are attending the 3 three hour sessions. Thirty people enrolled. We talked and were very open and honest about how we were feeling and what we saw happening individually and in the congregation.

Why did it take us almost a year to come to a decision? The most difficult part of the decision was the cost of \$4,000. In the end, Council believed this was so vital to the health of the congregation and our future ministry, that after months of conversation, we agreed to move forward. Our first session with Carol was February 2nd and our next is February 23rd. Other Business:

Bill Bishop, Chair of Trustees told the AGM that the congregation received a wonderful donation this year from the Estate of Wendell and Glenda Horton. The donation was divided - half to unrestricted funds for use by Council, half to Trustees restricted funds. Unrestricted funds are at discretion of Council.

11) Ministers' Comments -

Rev. Anne Dalziel Singer

"Anne thanked those gathered for the privilege that is hers as she spends time with folks who are not here today but in other homes and places, hospital, or their own homes. Rev. Anne highlighted a couple of things. Pastoral care visitors. When she began last May, Isabel Bowman suggested that they visit together for the first time. She said it was a wonderful time of caring and listening. To all pastoral care folk, sincere thanks.

She also highlighted the Eastlink ministry on Sunday morning. People watch regularly and they feel that they are part of the worship with us here. Rev. Anne told of one person who gets up on Sunday morning and dresses for church to be a part of the congregation on Eastlink. Thanks to everyone who makes the Eastlink broadcast possible.

· Rev. Melaney Matheson

Melaney reminded us of her history with Trinity-Clifton. She was with us before Rev. Cathie came, returned in summer when Greg went on sabbatical and was asked to continue on in this time of transition and discernment. She felt it was a privilege to be here and came to the conclusion that she really enjoys all the people who are here in this community of faith. "A privilege to be here to serve with you."

Rev. Cathie Crooks

Rev. Cathie thanked Lorraine, Andy, Ellen, Don, Melaney, Anne, the Council and Committees volunteering their time and gifts for all the ministries of the church. Special thanks to Mary Cowper-Smith and Gail MacNutt Co-Chairs of Ministry and Personnel who work to ensure that ministry of church is in good hands. And to thank them that transition to new Ministry leadership has gone so seamless. In all her years of

ministry, from her 1st year in Tatamagouche, she has never spent as much time in administrative work in a congregation until this past year. Very rewarding and grateful that ministries of the church continue on, and has appreciated working closely with Council and Ad Hoc Committee. She expressed excitement and hope working with Carol Gabanna wondering what the future may hold. The facts and figures can sound dire, but we should be encouraged by new families and in Sunday school as well. Stay on course and continue to pray. Thank you for the privilege to be one of the ministers in this place. Rev. Cathie closed with: "I returned from a week of vacation and walked into sanctuary... and I thought I was home... thank you for hanging in for this time of transition."

Since it is recommended practice that these files be backed-up on a hard drive and kept in an external location, Doug Kelly researched and found the best deal for a required back up system. He has offered to complete the transfer of files. The hard drive Doug suggested will be ordered and Emily will take the laptop to Doug and he will upload the files. (See motions below about payment)
- 4. **Printing of Minutes** (before originals are forwarded to Maritime Conference): As discussed in our last minutes, the plan is to either have a summer student do the photocopying or to send them to Kwik Kopy for copying. Chair Katherine will talk to Ellen about this plan and the decision will be made come summer. Any cost involved would come from the History and Archives 2018 budget.
- 5. **Hard Cover Record Book for Sunday School Records** As previously decided 12
- 6. during the meeting with Revs. Cathie and Greg, Chair Katherine bought a book for Rev. Cathie to record the list of Sunday School students and she has delivered the book to Rev. Cathie. This bill will be submitted to Ellen for reimbursement as well as the bill for the two framed document chronologies. These bills will be paid from this year's budget. (See below)

Katherine Dewar will also send a template to Rev. Cathie for recording Sunday School

statistical information at the end of the school year.

- 7. **Donation of two archival objects:** As decided at our last meeting and approved by council, Chair Katherine Dewar will deposit the Benjamin Chappell wallet and the CB Chappell sketch of the Wesleyan Church in the PEI Museum and Heritage Foundation Artefactory and PARO. Prior to the deposit, Chair Katherine was interviewed by Sally Coles of the *Guardian* for an article that will appear in connection with these artefacts for publication during Heritage Week.
- 8. **Reg Porter's work:** Following up on our last meeting, Chair Katherine forwarded Reg Porter's chapters for a proposed history of the church to Committee members. As Mr. Porter has completed more than originally planned, a motion was made to send him an additional \$200.00 honorarium for his exceptional work. (See below) Chair Katherine will request a formal consent for using the extra two chapters in a church history. Doug Kelly will upload these documents to the archive's computer.
- 9. **Chair Katherine Dewar** will request two paper copies of Trinity United Church's 2017 Annual report. One will be forwarded to Maritime Conference and one kept in the Archives Room.
- 10. **Chair Katherine Dewar** offered to arrange for Keltie MacPhail to continue updating the Archives collection on a twice-yearly basis. \$400 is already budgeted for this in the 2018 H&A budget.
- 11. **Chair Katherine Dewar** will review and update the Tour Guidebook for the Trinity Narthex.
- 12. **Motions:** There is a need to pay the bills already brought forward and those coming up throughout the coming year. With that objective, it was moved by Bob Ramsay and agreed by all present that money be paid to cover any current bills or bills arising throughout the year from the 2018 budget of the History and Archives Committee. These expenses include:
 - a) An external hard drive (\$169.99 plus tax)
 - b) The final two pictures for the photo gallery. (\$128.70)
 - c) The record book for Sunday School (\$25.00)
 - d) The book binding when this project is achievable. (time or cost unknown)
 - e) An honorarium for Mr. Reg Porter. (\$200.00)
 - f) Printing costs for minutes as required. (cost unknown)
 - g) Keltie MacPhail's maintenance of the Archives. (estimated cost \$400.00)

Outreach & Service

2019 Committee Members: Bernice Bell, Bev Bishop, Elizabeth Pippy, Evelyn Jenkins, Heather Cameron, Holly Burridge, Sylvia Gunn The Trinity-Clifton congregation is actively engaged in a wide variety of outreach activities, some of which are listed and described briefly below.

Unit 7- Hillsborough Hospital: Over the past 7 years, through September to June, the O & S committee has hosted the Unit 7 residents and staff for a monthly luncheon gathering. Initially, these events were held in the Chapel and consisted of a light lunch and a short movie with an occasional sing-along with Vans and Emily Bryant. After a number of years, it was suggested that we move to the much brighter and spacious gym. With the relocation, not only did our entertainment options expand to include crafts, games, dance and of course more music, but more importantly, our personal friendships and relationships with the residents and staff grew. Over the years we shared many celebrations – Birthday, Valentine's Day, Easter, Canada Day, Graduations, Concerts and of course Christmas. Our last celebration was a retirement party in June 2019, for Ann Atkinson. Ann, the supervising unit 7 nurse, who made all this possible and really got the ball rolling so many years ago, following her presentation to O & S in which she described her efforts and goal to provide a wide variety of stimulation, outings and opportunities for the Unit 7 residents under her care. O & S would like to thank all the past O & S committee members who continued to support and attend our Unit 7 Lunch dates over the years long after they had "officially" moved on to other committees – we couldn't have done it without all of you!

Prince Street School: The congregation continues to maintain its support of the Breakfast Program at the school. Trinity members have been very generous with their time and donations. As in previous years, many volunteers took part in the well-organized and delicious annual Pancake Breakfast fundraiser held in the spring. This year, O & S asked the congregation to donate school supplies in our Food Bank baskets through the month of September. These were gratefully received by the teachers as less than half the students are able to provide all the items appearing on their supply lists. We have also gathered new and slightly worn clothing for the PSS swap shop. Once again, this year, with the assistance of Chef Emily Wells and so many wonderful volunteers, we served a successful turkey dinner to the students and staff. We had enough leftover turkey, gravy, potatoes and carrots that we were able to deliver and provide a lovely hot turkey dinner to the patrons of the local Food Kitchen on Richmond Street! As in the past, we received and posted many cards expressing the student's deep appreciation of this opportunity to share a meal together as a class – for many, their favourite day of the school year. Thank you to

all the wonderful Volunteers who make this annual event possible and to Rev Greg, who still

manages to provide the "Haystack" warming containers needed for transportation.

Sisters In Spirit Vigil: Every October, communities across Canada come together to honour the Missing and Murdered Indigenous Women (MMIW) and to stand alongside their families to offer support, educate the public, and commemorate the lives of our Indigenous women and girls. This past year, Red Dresses were hung in the Sanctuary during the month of October and served as a powerful means of bringing awareness and attention to this national tragedy.

Stud Sponsorship: Habitat PEI has been actively building homes on PEI since 1999. Since then, they have built 61 homes of all shapes and sizes in all corners of Prince Edward Island. This past year, Trinity-Clifton United Church was able to support Habitat PEI's most ambitious undertaking ever, Vision 2020, with the purchase of a stud for \$250. There are over 300 studs used in each Habitat PEI build. Vision 2020, is a 3-year project which will ultimately see 20 families purchase a safe, decent, and affordable home. The priorities identified for this project are families living with disabilities, Canadian Forces veterans, refugees, and families traditionally left out of the housing market. Outreach and Services is hopeful that we can continue to expand the awareness and support of this community-based organization.

Food Bank Donations: This past year, O & S introduced collecting for the UPEI Food Bank which is run out of the UPEI Chaplaincy Centre under the direction of Sister Sue Kidd. We learned that the students were most in need in November and March and consequently, we collect during the previous months. It has really been a wonderful experience for those of us on the committee making the deliveries and witnessing the welcoming and inclusive atmosphere that is so warmly provided in this little haven tucked away in the middle of the campus. O & S also was asked to deliver the congregation's White Gifts to the Salvation Army this past year. Another eye-opening experience to see the enormous effort that the Salvation Army volunteers devote every year preparing and distributing the multitude of Christmas bundles to our local families in need. As in previous years, donations collected during the other months are picked up by the Salvation Army and distributed through their Food Bank.

Christmas Gifts Project: Once again, Mark and Sandra Richardson coordinated the Christmas gifts project which is funded by the Benevolent Fund Reserve. This year 66 senior individuals or couples received a remembrance from Trinity-Clifton United Church. This was either a small poinsettia plant purchased from Hearts and Flowers or a gift bag with 2 bottles of jam made at the church during the summer. The seniors were in 14 nursing homes/community care facilities and the QEH, as well as in 18 private homes. Included with the gift was a card with a handwritten message from the Trinity-Clifton congregation and signed by the clergy. Fourteen volunteers, including the clergy, made the deliveries from Clyde River to Belfast. The recipients were surprised, pleased, appreciative and grateful for being remembered by their church. Our thanks to all who helped in any way, especially to Don Wonnacott for his continued support and assistance.

Salvation Army and Shelters: Trinity continues to generously support the Salvation Army throughout the year with the donations collected in our Food Bank Baskets. In addition, our sanctuary annually hosts two fundraising Christmas concerts organized by the City of Charlottetown. This year an additional cheque of \$2500 from the Benevolent Funds was donated to the Salvation Army Christmas Kettle project in lieu of the annual Turkey Dinner. As in the past, \$4000 was donated from the Benevolent Fund to offset some of the expenses

incurred in preparation of the Christmas hampers. This year \$1500 was donated to each of the shelters Blooming House, Anderson House and Bedford MacDonald House from generous donations made

to the Benevolent Fund Reserve. The donation to Anderson House was in the form of thirty \$50 Walmart gift cards, which were provided to parents of children who had been guests during the previous year and were to be used to purchase Christmas gifts. Blooming House requested a \$500 Kent gift certificate and Walmart cards, as they intended to use the donation to purchase supplies to build individual storage lockers in the garage.

Property Committee

The Property Committee has the responsibility for:

- (a) Repair and maintenance of buildings and grounds, including capital initiatives
- (b) Implementation and monitoring of safety and security measures
- (c) Implementation and monitoring of energy efficiency measures
- (d) Maximizing building accessibility

Repair and Maintenance

Following the removal of the Aluminum Storm Windows for painting of the window frames on the 7 South Stained Glass Windows, it was discovered that there was very serious wood decay in all the window sills, wood arches and exterior wood frames. Estimates were received for reconstructing the window frames and installing new exterior glazing to protect the windows. A Congregational meeting was held to provide information on the situation and seek approval to proceed with the necessary repairs. The Meeting approved expenditures to a maximum of \$201,000. Restoration work and painting was completed in the Fall and the windows were

protected for the Winter by installing a clear PVC tarpaulin material. Consultations were held with Andrew McCausland Ltd. (Toronto) on permanent exterior glazing requirements. The 4 mm tempered glass, ventilated, single glaze exterior windows will be installed in 2020. The total cost to repair and provide exterior glazing for the 7 windows was approximately \$170,000. Preliminary examination of the exterior wood frames on the 7 Stained Glass Windows on the North side of the Church indicates that major restorative work is necessary as soon as possible. During the year, numerous repair and maintenance items have been carried out including: parking lot pothole repairs (\$3600), plumbing and electrical repairs in the Church and CEC, vinyl flooring in the Chapel (\$8000), Manse repairs, snow removal contractor (\$5900 maximum), turned posts replacement for the front lawn and assistance was provided through the New Horizons Senior Project.

Manse – The lease (\$15,000/year) for the existing tenants occupying the Manse was extended to July 31, 2020. Repairs to the manse included removing Asbestos on the basement heating pipes (\$3400), replacing the carpet on the bedroom level with solid Vinyl Tiles (\$4500), and maintenance on appliances.

Safety and Security

Meetings were held with the Charlottetown Fire Inspectors regarding maximum occupancy numbers for large attendance events and the requirements of the Charlottetown Fire Prevention By-Laws. The maximum occupancy numbers were established at total of 736 persons with a maximum of 264 persons in the Balcony. The Charlottetown Bylaws exempts the requirement of automatic sprinklers for assembly occupancies for Religious Worship. Entertainment occupancies over 300 persons require a sprinkler system. The TUC Insurance Broker advised that, if the legal Fire Safety Codes are not followed and a major safety incident occurred, the insurance coverage could be in jeopardy. Because commitments had already been made for 3 large attendance Christmas Concerts, the TUC Council decided the Concerts would go ahead on a one-time basis. The New Horizon Senior Project repaired the concrete sidewalks, installed handrails and replaced the steps for the two side doors on Prince Street.

Locksets were installed on the fire doors in the basement and on the interior doors in the Narthex.

An inspection of the ventilation system in the basement determined there is not any air inlet supply.

A CPR and AED training event was conducted for staff and other interested persons. Efforts were made to obtain a volunteer as the Fire Safety Administrator. The position remains vacant.

Energy Efficiency and Lighting

Due to lamp safety concerns with the Sanctuary ceiling pot lights, the use of these lights was discontinued. The pot lights were replaced with 4 energy-efficient High Bay LED lights on dimmers.

High Amperage electrical receptacles were installed at the front and back of the Sanctuary for the Audio and Lighting systems for the large entertainment events. Electrical receptacles were installed at the back of the Sanctuary to power the water coolers. Three security lights, controlled by motion sensors, were installed in the Alcove between the Church and the CEC.

Building Accessibility – The New Horizons Seniors Program provided the money and

supervision of the concrete sidewalk repairs, over 100 feet of handrail upgrades, new steps for the two Prince Street side doors and installation of the turned posts on the Front Lawn.

Thanks to Council and Trinity staff for your continued support and assistance. Thanks also to Committee Members for their commitment and participation at monthly meetings, assisting with maintenance projects and developing plans for the major projects.

New Horizons for Seniors Report

New Horizons for Seniors is a federal grant program designed to improve the quality of life for Canadian seniors. Trinity -Clifton United Church was grateful to have received a New Horizons for Seniors grant for a project entitled, *Safer Spaces and Sensitive Social Support*. The timeframe for this project was March 2019 - February 2020.

A small Planning Committee was formed to oversee this project and ensure that all components of the project were completed. We sincerely thank The New Horizons for Seniors Program for providing a grant of \$24,900. This church community provided hands-on and in- kind resources.

The Project was implemented in partnership with the Property Committee and the Pastoral Care Committee.

The success of this project is evident by new steps and railings at the two side Prince Street entrances making entering this building safer. Significant sidewalk cracks were repaired and turned fence posts were replaced. Inside the complex, 100 + feet of handrails were added or adapted making the environment safer. Forty- four senior friendly chairs are now enjoyed while new quality microphones enhance sound in the sanctuary and the gymnasium.

During the project, verbal feedback and survey results indicated satisfaction with the improvements. A busy construction year however, led to delays in the physical renovations and progress was slow. With volunteer expertise, hands-on work, and close monitoring by the Property Committee, all of the construction was finished before winter weather set in. The sidewalk was finished at the last possible day!

In late December plans were in the works to prepare a workshop to be held early in 2020 working with the Pastoral Care Committee. A training day on Sensitive Social Support is planned with a goal of implementing a Social Support Network. Volunteers will be prepared to offer a telephone or email connection to listen, cheer and inspire individuals in our congregation who are in need of additional support.

The physical improvements and the social support network resulting from this project will have a lasting and positive impact on Trinity- Clifton United Church.

Ministry & Personnel Committee

This ministry involved visitation with congregants in their 'home', wherever that may be, as well as in hospital in Rev. Crooks' absence. Rev. Dalziel-Singer also attended the Pastoral Care Committee meetings.

Rev. Melaney Matheson completed her part-time ministry appointment in Worship and Christian Development on June 30, 2019. A reception was held in the gym with presentation of a thank you

gift and well-wishes from the Council and congregation in recognition of her time at Trinity Clifton.

The last half of the year was a very trying time for the M&P Committee as it was called upon to investigate a concern raised. Many weeks were given to conducting this work. Regional Council resource support was sought and received. Due to the nature of the concern, M&P was unable to communicate details to the Council or congregation during this time.

Rev. Crooks' current leave to provide clergy coverage with Rev. Anne Dalziel-Singer on a part time basis, including attendance at Council and Worship Committee. We are grateful to both for their ministry with us.

The M&P Committee sincerely thanks Trinity-Clifton staff and congregation for their continued work and support.

Affirm Committee

On February 14, 2020, Trinity-Clifton Pastoral charge celebrated their fourth Anniversary as an Affirming Ministry.

Affirming Ministries are congregations, presbyteries, Conferences, educational institutions, and other ministries within the United Church of Canada that publicly declare their commitment to inclusion and justice for people of all sexual orientations and gender identities. Although Affirming Ministries make an explicit statement about issues of sexuality and gender, their commitment to justice is far broader.

As an Affirming Ministry of the United Church of Canada's Affirm United, Trinity-Clifton was required to create a Vision Statement that guides their work. The following Vision Statement was approved at a congregational meeting on May 24, 2016 and reflects this commitment.

Vision Statement adopted May 24, 2016.

We, the Trinity-Clifton Christian family, believe that God has blessed us with diversity, including diversity in sexual orientation, gender, gender identity, race, age, ability and faith. We believe that Jesus challenged boundaries by reaching out to all people, welcoming and honoring all in their uniqueness.

We publicly declare our commitment to openness, growth, action, and education, honoring diversity and challenging injustice in solidarity with those who experience discrimination.

We offer our resources and talents with open hands and hearts in love and service to all as we $30\,$

work for reconciliation and justice locally, regionally, and globally.

Committee members for 2019 were Valerie Downe (Co-Chair), June Jenkins Sanderson (Co-Chair),

Jane Farquharson (Recording Secretary), Reverend Gail Hopkirk and Mary Anne Burke - Matheson. We were supported in our work by Reverend Cathie Crooks as Clergy.

The Affirm Steering Committee is an Ad-Hoc Committee, reporting directly to Church Council. This committee will be re-appointed on an annual basis until such time as it is deemed appropriate to return to the purview of the Outreach Committee. The nomination process for members to this committee will follow the established procedural rules set by Church Council for all Standing Committees.

The work of the Affirm Committee in 2019 was guided by input from our community partners. Their input helped us identify areas of need from which we developed our Action Plan, which was then presented to Council on February 7, and reviewed with Standing Committees of Council. A few highlights are mentioned below.

Book Club: February 6: In recognition of Black History Month, we chose to read "Americanah", a powerful and tender story of race and identity by Award-winning author Chimamanda Ngozi Adichie.

We also watched the video "The Danger of a Single Story". Special thanks to Bev Bishop, Monica MacDonald, and Gillian for their leadership.

Support for PEERS Alliance training:

The committee made a donation to this group to cover training for a youth facilitator for their monthly meetings. PEERS Alliance staff and volunteers have been key to informing the work of the Affirm Committee.

Justin Milne, a young Lawyer and legal scholar on LGBTQ rights was invited by the Affirm Committee to speak to the Supper Club on May 7, 2019. Justin's topic was samesex equality, rights and freedoms of religion.

In the Spring, Trinity-Clifton was invited by Affirm United to participate in the making of a fifteen-minute video for PIE Day on March 14. PIE stands for congregations which are

Purposeful, Intentional, and Explicit in their welcome to the LGBTQ community. This was an honor to be recognized as an Affirming Ministry which lives out their commitment. A celebration was held in the sanctuary to view the video and all who attended were treated to delicious small pies.

A Diversity service was held on June 23, to coincide with The DiverseCity Festival. The theme for the service was: Healing Our Beautiful and Broken World Together. The guest presenter was Dr. Sobia Ali-Faisal who spoke of Islamic Feminism for Liberation and Peace. Snacks from many countries were shared in the sanctuary following the service.

On July 21, Trinity-Clifton was asked to host a Pride Celebration Service during PRIDE week on PEI. We were honored to have the Reverend Karen Oliveto, Resident Bishop, United Methodist Church, Rocky Mountain and Yellowstone Conferences of the Episcopal Church as the Guest Speaker. During the PRIDE service an Affirming parament, created by congregants Eileen Howatt, June Ives, Monica MacDonald and Roberta Giddings, was blessed by Rev. Cathie Crooks. Our thanks to Affirm Committee members Reverend Gail Hopkirk and Jane Farquharson for their inspiration and guidance on this project. The service closed with a blessing often used at the

Corrymeela Centre for Reconciliation: "Your voice is unique here and You are welcome".

Members of Trinity-Clifton also participated in the PRIDE Parade, some in a rainbow-decorated golf cart and others walking. The 2019 Pride Parade organizers were: Mary Anne Burke — Matheson, Jane Farquharson, and Jackie McKinnon. Rounding out the Team on the big day were other members of the Affirm Committee, Ministry and Personnel, and Outreach committees, their friends, family members and other members of United churches on PEI. Participants were often joined by supporters from the sidelines to walk a short distance. Several joined to walk the entire parade route. It was an uplifting event, creating spirit, and enhancing community outreach.

In addition, Trustees are responsible for holding, investing and distributing funds that have been endowed to the church as well as funds entrusted from church council. Any investment decisions are dictated by our Investment Policy.

In 2019 Trustees met as a group in June and November. The Investment Committee meets more frequently primarily with our investment advisors at RBC/Dominion Securities. Our investments are relatively conservative in line with the due diligence required with the funds that have been entrusted with us. Our portfolio is impacted by donations, interest, dividends, capital gains and distributions. As can be seen from the financial statements a significant portion of our income is paid out annually to specific endeavours within our church.

The board of trustees holds in-trust title to the property at Clifton for the use and benefit of the congregation on behalf of the United Church of Canada. In addition, the trustees hold in-trust and administer funds that have been given to Clifton Cemetery as a result of plot sales, donations, and bequests to ensure the perpetual care of the cemetery.

In 2007 Clifton United Church was designated a heritage place under PEI's <u>Heritage Places Protection Act</u>. This designation confers ongoing legal protection to the structure. The congregation established a fund named the "Heritage Building Preservation Fund" for the perpetual care and preservation of the church building. Brace Block

The Brace Block Trust, which provides financial assistance for those enrolled in theological college and intending ordination in one of the Protestant denominations in Prince Edward Island, was established in 1930 (by a legislative incorporation) with a bequest from Charlottetown businessman Richard Brace. With his bequest the Trust built the Brace Block on Queen Street (now largely concealed by the Confederation Court Mall) and used the revenue to provide the support in the form of bursaries. The Brace Block was sold in the 1970s and the sale revenue was invested to provide the bursaries.

The Trust is administered (under a Legislative incorporation) by six Trustees, one ordained and one lay from each of 1st Baptist, Zion and Trinity. In 2019, Trinity was represented by Rev. Anne

Dalziel-Singer and by myself as lay member and Chair.

A few years ago, there had been discussion re the possible need to expand eligibility for bursaries beyond the traditional programs of ministry to attract more applicants. However, the Trust has more recently been encouraged by the continued interest expressed in the established program.

In 2019, the Trust awarded five bursaries...three U.C.C. recipients (Calvin Burt, Rhonda Schofield, Catherine Dickson), two Presbyterian (Chad Bolton, William Henbest), and one Baptist (Tyler Proude).

Special Gifts To Trinity - Clifton Pastoral Charge

Did you know that you can make a special gift to Trinity United Church and get a tax receipt and also save on Capital Gains Taxes? The following examples illustrate some of the ways this may be accomplished.

Life Insurance

If you donate a permanent life insurance policy to Trinity United Church, and it becomes the owner and beneficiary of the policy, you will receive a tax receipt for the value of the sum of the cash surrender value plus any accumulated interest and dividends that are also donated.

If you continue to make the premium payments on the policy, these payments will also be considered charitable donations and will be available to you as a tax credit.

The important thing is that Trinity must become the owner of the policy. You will not get these tax benefits if you only make Trinity the beneficiary of the policy. *This does_not apply to term policies.*

Capital Gains Tax

The present law provides that if you realize a Capital Gain on the sale of an asset such as shares

in a company, you must include 50% of the Capital Gain as Income and pay tax at your marginal tax rate. If however, you donate the assets of such, as shares, to Trinity United Church, you would have a deemed capital gains and would only have to include 25% of the capital gains as income instead of 50% if you sold the shares and kept the money for yourself. You would get a tax receipt for the value of the asset donated to the church.

Wills

You can also make a gift to Trinity United Church by means of your Will. Such a gift is called a bequest and only takes place after death.

You may leave a bequest outright to the church which means the congregation decides how the money is to be spent or you can leave the bequest in a manner that the principal sum remains invested and the congregation can only use the annual income (interest) earned on the bequest. You are free to designate how and for what purpose the bequest is to be used.

More detailed information may be obtained from an Estate Planner, a Lawyer, or a Tax Expert.

Cathie Crooks who has provided support, encouragement, and spiritual guidance. As well, we appreciate the support provided by other clergy members for the UCW and its activities. Thank you to Council Chair, Barb Prowse for responding to questions from the group and for her hard work. We also appreciate the assistance of Ellen Locke Doiron, Lorraine Worth, and Andy Gagnon who have helped us with our many functions during the year.

Sympathy is extended to all Members and Adherents of Trinity-Clifton who were bereaved over the past year. This year we acknowledge with sadness the passing of a number of very involved and hard-working UCW members for whom we had a memorial service at our Annual General Meeting in December. We especially want to remember Isabel Bowman who was always a most willing volunteer, as well as Betty MacEachern and Marguerite Wood, both Past-Presidents of UCW.

The UCW is involved in many aspects of the life of our Trinity-Clifton Community of Faith. One of the major functions is the Annual Lobster Supper held in conjunction with the Men's Group. This year the supper was held on a Saturday instead of a Wednesday, a move which had both pros and cons, and which will soon be further explored. Some of the other ways in which our UCW has contributed to the life of Trinity-Clifton include catering to a number of funeral receptions, participating in the annual Plant/Bake/Book Sale and in many aspects of the Christmas Fair, providing preparation for and clean-up after Communion, gifting Trinity-Clifton with new "Greeter"

Development Committee Report

The Development Committee operated on a limited basis in 2019. In May, Trinity hosted concerts presented by the 2019 East Coast Music Awards hosted by Music PEI. The entertainment was enjoyed by enthusiastic audiences, and entertainers were most complimentary in their comments about our wonderful sanctuary and its excellent acoustics. We had hoped the ECMA's would be a springboard to a successful musical season.

During this approximate time period a review of a number of physical issues in our sanctuary, of potential concern, was under way; issues that eventually led to certain aspects of our sanctuary being identified as failing to comply with minimum building code, and/or fire safety standards, for large audiences. The Property Committee and subsequently Council, out of necessity, placed a moratorium on large concerts in June. Regrettably, costs required to correct the identified shortcomings were prohibitive and the moratorium remains in effect.

When Council authorized the formation of the Development Committee in 2017 it did so with the

understanding the committee would review its operations in two years and determine its future at that time. In September 2019, the committee arrived at the difficult decision to discontinue operating, allowing its members to devote their talents to other committees of Council.

Lennie Gallant performed his annual Christmas Concert in December to conclude the Development Committee's operation.
